**EMERGENCY ORDER**

---

Acting under the authority of La. R.S. 1:55 (E)(2), and considering the Parish-wide state of emergency declared by Parish President, Gordon E. Dove on August 26, 2021, due to Hurricane Ida's impending landfall along the Louisiana coast; and

Considering that Hurricane Ida struck the Louisiana coast, in particular Terrebonne Parish, as a Category 4 Hurricane causing enormous destruction, instability and interruption of normal daily services provided by the office of the Terrebonne Parish Clerk of Court; and

Considering that the personnel involved in the operations of the Courts, including the Office of the Clerk of Court, were released from duties in order to tend to their families, homes and properties on August 27, 2021, all in order to minimize the effects of the damages that occurred as a result of Hurricane Ida.


**I, THERESA A. ROBICHAUX, CLERK OF COURT. DO HEREBY DECLARE** than an emergency situation still exists due to damage to the office of the Terrebonne Parish Clerk of Court, which renders it hazardous or otherwise unsafe for employees of the Terrebonne Parish Clerk of Court to continue in the performance of their official duties and for the general public to conduct business with the Terrebonne Parish Clerk of Court.

**THEREFORE**, the office of the Terrebonne Parish Clerk of Court shall remain closed from **MONDAY**, the **30TH** day of **AUGUST, 2021**, until and at least through **FRIDAY**, the **24TH** day of **SEPTEMBER, 2021** at 4:30 o'clock p.m.

If conditions require that the office of the Terrebonne Parish Clerk of Court remain closed beyond the **24<sup>TH</sup>** day of **September, 2021**, notice of the extension of said closure will be posted at [www.terrebonneclerk.org](http://www.terrebonneclerk.org).

These days of closure shall be considered legal holidays as provided by La. R.S. 1:55 (E)(3).


**ORDER**
